**COFFEYVILLE RESOURCES REFINING & MARKETING, LLC PUSHES TOWARD RECOVERY  
ENTERS INTO ADMINISTRATIVE ORDER ON CONSENT WITH EPA**

COFFEYVILLE, Kan. (July 10, 2007) -- Coffeyville Resources Refining & Marketing, LLC announced today that it has voluntarily entered into an Administrative Order on Consent with the U.S. Environmental Protection Agency to respond to a release of oil from the refinery caused by record flooding from the Verdigris River on July 1, 2007. The order describes Coffeyville's commitment to conduct a timely and thorough clean-up of oil impacted areas.

"We appreciate the efforts of EPA in working with Coffeyville Resources to develop an effective strategy for responding to the release," said Jack Lipinski, CEO of Coffeyville Resources. "The agreement with EPA describes Coffeyville Resources' ongoing efforts to remove oil discharged from the refinery, to assess affected areas, and to continue to ensure that public water supplies are not impacted by the release."

The Administrative Order on Consent outlines specific measures of success that will guide Coffeyville Resources in its efforts.

"We are absolutely committed to supporting our community through this difficult time," said Keith Osborn, executive vice president and general manager of the refinery. "We appreciate the experienced guidance of the EPA and state and federal emergency management organizations as we work toward recovery."

During the weekend of June 30-July 1, heavy rains caused the Verdigris River to overflow its banks, top protective levees and flood the town of Coffeyville. The river crested more than 10 feet above flood stage, setting a new record for the river. Approximately 2,000 citizens and more than 200 homes were affected. In addition, the Coffeyville Resources refinery and nitrogen fertilizer plant, and many local businesses were flooded.

As floodwaters began rising much faster than had been predicted, officials at the Coffeyville Resources refinery and fertilizer plant ordered the facilities shut down and evacuated. Despite Coffeyville Resources' efforts to secure the refinery prior to the evacuation, an estimated 1,700 barrels of crude oil and a small amount of oil from the refinery's sewer system were swept away by flood waters.

EPA has conducted monitoring for the presence of volatile organic compounds in flood waters in Coffeyville and downstream, but has not indicated the presence of these compounds at a “level of concern.” For more information on Coffeyville Refinery, its community recovery efforts, and current activities, please visit [www.coffeyvillegroup.com](http://www.coffeyvillegroup.com).

Coffeyville Resources has established a toll-free number to help local residents file claims related to the discharge of oil. The toll-free number, which will be answered 24 hours a day, 7 days a week, is 1-800-958-5380.

Call center operators collect the property owners’ information and then forward it to our claims adjustors. The claims adjustors will contact the property owners to schedule appointments as soon as possible. Operators also will be able to direct callers to local, state and federal disaster response agencies for additional assistance.

In addition, the company established a claims office, located at 900 Hall Street in Coffeyville, to assist local residents file oil-related claims. The office hours for oil-related claims assistance are 7 am to 8 pm.

Claims office staff also will assist flood victims with online filing for FEMA individual assistance. Computer terminals have been provided for residents at the office, and volunteers will be on hand to help residents with questions and technical assistance in filling out their applications. Kansas and Oklahoma flood victims are invited to apply for FEMA assistance between the hours of 9:00 am and 7:00 pm.
